3. **Breakfast and Preview will be from 9-10.**
4. **The auction will start at 10:00 sharp.** Since we don't have to clear up for a luncheon, the auction can last until 12:30 or 1:00. **There will be cookies and coffee available for the duration of the auction.**

Don't forget to get your clocks consigned for the June Auction. Once again, there is no charge to sell your clock. You need to get the information to Cathy no later than May 19th. In an attempt to be more clear to the general public about the condition of the clocks, the Directors have instructed that only the following descriptions be used:

Make, Model and year (approx) of manufacture if known. If not, please indicate if the item is antique (100 years or so +), vintage (less than 75 years) or modern. Condition should be described as running or not running. No comments about the clock having been serviced, as that has different meanings to

different people. Also please indicate any alterations to case or movement (i.e. replaced parts, refinished case, etc.) if known.

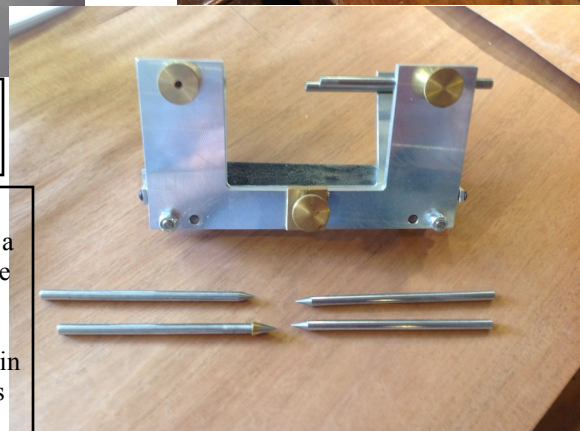
